New Congressional Lines Split McLean County, Twin Cities

The newly-drawn congressional districts mean new district boundaries and potentially new representatives for Bloomington/Normal and McLean County.

Incumbent Rep. Tim Johnson's(R) district was redrawn and he now finds himself running for re-election in the 13th congressional district, where he will face off against Republican challengers Frank Metzger and Michael Firsching. On the Democratic side, David Gill, who is running for the fourth time, faces off against political newcomer Matt Goetten.


The 13th district encompasses much of McLean Count,y including the east sides of the Twin Cities.

The rest of Bloomington/Normal and the county fall into the 18th district, where Republican congressman Aaron Schock is running to serve a third term. He faces a primary challenger in Republican Darrel Miller. On the Democratic side, Matt Woodmancy and Steve Waterworth compete for the chance to run in the November general election.

The Illinois primary is Tuesday, March 20. The Advocacy Council plans to send a candi-

Where Do We Go from Here? 2012

MLK Day, January 16, 2012

Martin Luther King wrote: "Now, in order to answer the question 'Where do we go from here?' we must first honestly recognize where we are now."

On King's day we had much to celebrate. Today I ask you to think of the challenges that remain:

- Queer teenagers are much more likely to attempt suicide than their straight peers.
- If a US citizen happens to fall in love with a foreigner of the same gender then that foreigner cannot become a permanent resident even if the couple somehow manages to marry.
- In all but six states, a couple of the same gender cannot marry and is either relegated to the second-class status of "civil union" or has no status whatsoever.
- Mainstream movies generally depict all kinds of sexual and gender nonconformists as tragic figures at best, often as victims, as morally corrupt or even as murderers.
- In real life, sex workers, homosexual or heterosexual, are exploited and treated as criminals
- Transgender teenagers are not allowed reassignment surgery or hormones but are forced to wait until they are older, when the transition is much more difficult.
- In any public place in Chicago, for example, or nearly any hospital, one must define their gender identity – male or female – in order to obtain access to the toilet.
- In many or most states of the Union, a transgender person must submit to genital surgery, and document the fact, in order to receive an appropriate driver's license or state ID.
- Homosexual activity around the world is a crime punished by death, mutilation or long prison terms.

How did this come about? You have individuals, frequently male and occasionally gay, at all levels, who choose to or feel compelled to oppress those who are female or who do not conform physically or psychologically to the stereotypes of our culture. This may be about money or it may be expressed in other power relationships. Convinced that we have few options, many of us put up with it. Others simply give up.

He went on to say,

"The tendency to ignore the Negro's contribution to American life and to strip him of his personhood, is as old as the earliest history hooks and as contemporary as the morning's newspaper. To upset this cultural homicide, the Negro must rise up with an affirmation of his own Olympian manhood. Any movement for the Negro's freedom that overlooks this necessity is only waiting to be buried. As long as the mind is enslaved, the body can never be free. Psychological freedom, a firm sense of self-esteem, is the most powerful weapon..."

He could have been talking about us.

Again quoting King, one of the great problems we confront is our own lack of power. Power was the ability of King to make the white male-dominated US legislature say "yes" when it wanted to say "no." That was power.

I sometimes feel that I don't deserve to have political power. Where does that idea come from? Somewhere in the history books or in the churches, I got the idea that love and power were opposites, that "love is identified with a resignation of power, and power with a denial of love." But we cannot afford to be confused about this: neglect of our rights and the rights of our children is not love. It is just neglect.

What would love be? Love could be expressed in the following ways:

Deletion of the "sodomy" laws that are on the books across the nation

Gav-straight alliances in all the schools

Designated administrators legally required to respond to any violent incident in the public schools

Decriminalization of sex workers, male and female

Marriage recognized by the Department of Homeland Security (formerly the Immigration and Naturalization Service). (It is ironic that sexual orientation has now become an issue of national security.)

Universal recognition of corporate domestic partner benefits.

Gender-neutral toilets in hospitals and public places

Would this type of progress be a threat to families? Yes. It is a threat to families based on women's shame at being single, upon men's need to prove their worth to the community, based on fear of being different from the majority, based on guilt about sexual expression by single people.

Is this a threat against organized religion? Yes it is that, too. This is a threat to organized religion that is based on guilt or the quest of a priesthood for power.

I know that many of you, perhaps most of you, are already working towards what I advocate. What I have a problem with
